## Mini-souris optique USB et PS/2 IBM

Dans le présent guide, vous trouverez des informations relatives à l'installation, l'utilisation et la maintenance de la mini-souris optique USB et PS/2 IBM.

---

### Description du produit

Souris mobile, la mini-souris optique vous fera gagner de la place sur votre bureau, en voyage ou au bureau.

La souris fonctionne avec les ordinateurs IBM ou compatibles IBM dotés du système d'exploitation Microsoft Windows 98, Microsoft Windows Millennium Edition (Me), Microsoft Windows 2000 Professional ou Windows XP et qui prennent en charge la connectivité USB. De plus, la souris peut être raccordée aux ports PS/2 IBM sur les ordinateurs ayant pour système d'exploitation Windows 95 ou Microsoft Windows NT.

**Remarque :** Si vous connectez la souris à un ordinateur portable équipé d'un dispositif de pointage intégré, par exemple un ThinkPad IBM, ou que vous utilisez un clavier doté d'un dispositif de pointage intégré, vous devez désactiver celui-ci avant d'installer et d'utiliser la souris.

Le présent coffret contient :

- Une mini-souris optique dotée d'un connecteur USB ;
- Un CD-ROM contenant le logiciel d'installation de la mini-souris optique et un manuel d'utilisation en ligne ;
- Un adaptateur USB-PS/2.

### Installation du logiciel Mouse Suite

Dans le présent coffret, vous trouverez un CD-ROM contenant le logiciel d'installation de la souris. Pour installer le logiciel Mouse Suite, procédez comme suit :

1. Mettez l'ordinateur sous tension et démarrez Windows.

2. Insérez le CD du pilote de périphérique dans l'unité de CD-ROM. Cliquez sur la flèche **Driver**. Suivez les instructions qui s'affichent à l'écran. Si le programme d'installation ne s'ouvre pas, passez au étapes 3 à 6. S'il s'ouvre, passez à l'étape 6.
3. Cliquez sur **Démarrer**.
4. Cliquez sur **Exécuter**.
5. En ligne de commande, tapez `X:/setup` (où X désigne l'indicatif d'unité de votre unité de CD-ROM). Par exemple, si l'indicatif de votre unité de CD-ROM est E:, tapez `E:\Setup`.
6. Cliquez sur **OK**.
7. Suivez les instructions qui s'affichent pour mener à bien l'installation du logiciel Mouse Suite.

**Remarque :** Lorsque vous êtes invité à sélectionner une interface, cliquez sur PS/2 ou sur USB selon que vous prévoyez de connecter la souris au port souris standard ou au port USB.

L'installation du logiciel Mouse Suite est terminée. Passez à la section "Installation de la souris".

## Installation de la souris

La présente section contient des informations relatives à l'installation de la souris en mode PS/2 et en mode USB.

### Installation de la souris en mode PS/2

1. Mettez l'ordinateur hors tension.
2. Déconnectez la souris du port PS/2.
3. Raccordez la souris dotée de l'adaptateur PS/2 au port souris de l'ordinateur.
4. Redémarrez l'ordinateur.

Si vous installez la souris en mode PS/2, arrêtez l'ordinateur, puis branchez la nouvelle souris en veillant à ce qu'elle soit raccordée à l'adaptateur PS/2. Redémarrez l'ordinateur. Passez à la section Utilisation de la souris, dans le présent manuel (page 1-3). Votre souris est prête à être utilisée.

### Installation de la souris en mode USB

Si vous utilisez actuellement une souris PS/2, commencez par mettre l'ordinateur hors tension avant de retirer la souris. Vous pouvez ensuite brancher la souris et redémarrer l'ordinateur. Si un message s'affiche, indiquant qu'aucune souris PS/2 n'est connectée, ignorez-le et continuez.

Installation de la souris en mode USB sous Windows 98 et Windows 2000 :

1. Branchez le connecteur USB (rectangulaire) de la souris dans le port USB de l'ordinateur. La fenêtre "Nouveau matériel détecté" s'ouvre, suivie de l'assistant Ajout de nouveau matériel.
2. Appuyez sur la touche **Entrée**. La fenêtre "Que voulez-vous faire ?" s'affiche.
3. Sélectionnez **Rechercher le meilleur pilote pour votre périphérique**.
4. Appuyez sur la touche Entrée. La fenêtre "Windows va rechercher des nouveaux pilotes" s'ouvre.
5. Appuyez sur la touche Entrée. Votre ordinateur affiche l'emplacement du pilote.
6. Appuyez sur la touche Entrée. La fenêtre "Windows a terminé l'installation du logiciel nécessaire à votre nouveau périphérique matériel" s'affiche.
7. Appuyez sur la touche Entrée pour terminer l'installation.

Pour savoir comment utiliser la souris, reportez-vous à la section "Utilisation de la souris" à la page 1-3.

### **Installation de la souris en mode USB sous Windows Me et Windows XP :**

Pour installer la souris en mode USB sur un ordinateur doté de Windows Me ou de Windows XP, procédez comme suit :

**Remarque :** Ne connectez pas la souris à un port USB d'un ordinateur ThinkPad tant que le bureau Windows Me ou Windows XP n'est pas affiché.

1. Branchez le connecteur de la souris dans le port USB de l'ordinateur.
2. La fenêtre "Nouveau matériel détecté" s'affiche et contient le message "Windows installe le logiciel pour votre nouveau matériel". Windows Me et Windows XP installent automatiquement les pilotes de périphérique nécessaires au fonctionnement de la souris.

## **Utilisation de la souris**

Grâce aux nombreuses fonctions offertes par la mini-souris optique, telles que le zoom et le défilement automatique, vous allez constater une hausse de votre productivité. Vous pouvez également associer des fonctions que vous utilisez fréquemment ou des raccourcis aux boutons de la souris, à l'aide des différentes pages du logiciel Mouse Suite.

Pour lancer le logiciel Mouse Suite, procédez comme suit :

1. Cliquez sur **Démarrer --> Paramètres --> Panneau de configuration**.

2. Le panneau de configuration s'ouvre. Cliquez deux fois sur l'icône représentant une **souris**. (Si vous avez déjà activé l'option Show Mouse Icon in the system tray, dans les propriétés du logiciel Mouse Suite accessible via le panneau de configuration, cliquez deux fois sur l'icône **Souris** de la barre d'état système Windows située dans l'angle inférieur droit de l'écran.)

Par défaut, certaines fonctions sont associées aux boutons de la souris, par exemple, la fonction de bouton principal, de menu contextuel et de défilement rapide/automatique. Vous pouvez toutefois personnaliser ou modifier ces affectations. Pour personnaliser la fonction de chaque bouton, procédez comme suit :

1. Ouvrez le panneau de configuration de **Mouse Suite**.
2. Cliquez sur l'onglet **Buttons**.
3. Sur l'image de souris qui s'affiche, cliquez sur le bouton auquel vous voulez associer une nouvelle fonction, ou sélectionnez un bouton dans la liste. Le bouton choisi s'affiche dans la liste des boutons et est mis en évidence sur la représentation de la souris.
4. Dans la liste des fonctions, choisissez la fonction voulue (vous devez désigner au moins un bouton comme bouton principal de la souris).
5. Pour restaurer les valeurs par défaut des boutons, cliquez sur **Use Default**.
6. Pour confirmer les nouveaux paramètres, cliquez sur **Apply**.

Pour plus d'informations sur la personnalisation des paramètres, cliquez sur le bouton d'**aide**, qui se trouve dans l'angle inférieur droit de l'interface Mouse Suite.

## Résolution des incidents liés à la connectivité USB

La présente section contient des informations relatives à la résolution des incidents liés à la connectivité USB.

**Remarque :** Il arrive parfois que des ordinateurs soient physiquement dotés de ports USB mais que le BIOS ne les prenne pas en charge. Dans ce cas, vous devez prendre contact avec le constructeur de l'ordinateur pour mettre à niveau le BIOS.

### La mini-souris optique ne répond pas.

- Vérifiez que l'ordinateur est sous tension. Il se peut que vous ayez connecté la mini-souris optique alors que l'ordinateur était hors tension. Essayez de la déconnecter puis de la reconnecter.
- Vérifiez que vous n'utilisez pas Windows 95 ou Windows NT : ces systèmes d'exploitation ne prennent pas en charge le bus USB.



- Si vous utilisez Windows 98, Windows Me ou Windows 2000, vérifiez que tous les commutateurs USB du BIOS sont activés. Pour activer le port USB, vous devez exécuter le programme de **configuration (Setup)** de l'ordinateur en appuyant sur l'une des touches suivantes au cours de la séquence d'amorçage : F1, F2 ou Suppr. Si vous ne savez pas comment exécuter ce programme, reportez-vous à la documentation livrée avec l'ordinateur ou prenez contact avec le constructeur de votre ordinateur.

### Réitération de la détection du contrôleur de bus USB (Universal Serial BUS)

Le contrôleur USB (Universal Serial BUS) peut ne pas être correctement installé dans votre ordinateur.

1. Cliquez deux fois sur **Poste de travail**.
2. Cliquez deux fois sur **Panneau de configuration**.
3. Cliquez deux fois sur **Système**.
4. A l'aide du bouton gauche de la souris, cliquez sur l'onglet **Pilote de périphérique**.
5. Faites défiler la page jusqu'à ce que vous voyiez Contrôleurs de bus USB. A l'aide du bouton gauche de la souris, cliquez alors sur le signe plus (+) en regard de cet élément ; il se transforme en signe moins (-).
6. A l'aide du bouton gauche de la souris, cliquez sur le bouton **Supprimer** situé dans l'angle inférieur droit du gestionnaire de périphériques. Un message vous avertit que vous allez supprimer ce périphérique du système.
7. Cliquez sur **OK**.
8. Cliquez sur le bouton **Actualiser** afin de forcer Windows à détecter de nouveau le matériel.

Cette procédure permet de détecter à la fois le contrôleur hôte USB et le concentrateur USB racine. Vous pouvez être invité à insérer le CD d'installation de Microsoft Windows.

## Entretien de la souris

Avant de nettoyer la souris, veillez toujours à la déconnecter. Eloignez toute boisson de la zone de travail de la souris afin d'éviter de renverser du liquide sur cette dernière. Une maintenance régulière de la souris augmente sa durée de vie et réduit le risque d'endommager la souris et l'ordinateur. Aucune pièce ne peut être remplacée par l'utilisateur.

The term «Machine» does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

#### The IBM Warranty for Machines

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications («Specifications»). The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded.

### **Extent of Warranty**

The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.

### **Items Not Covered by Warranty**

IBM does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance via telephone with «how-to» questions and those regarding Machine set-up and installation, will be provided **WITHOUT WARRANTIES OF ANY KIND.**

### **Warranty Service**

To obtain warranty service for a Machine, contact IBM or your reseller. If you do not register your Machine with IBM, you may be required to present proof of purchase.

During the warranty period, IBM or your reseller, if approved by IBM to provide warranty service, provides without charge certain types of repair and exchange service to keep Machines in, or restore them to, conformance with their Specifications. IBM or your reseller will inform you of the available types of service for a Machine based on its country of installation. At its discretion,



IBM or your reseller will 1) either repair or exchange the failing Machine and 2) provide the service either at your location or a service center. IBM or your reseller will also manage and install selected engineering changes that apply to the Machine.

Some parts of IBM Machines are designated as Customer Replaceable Units (called «CRUs»), e.g., keyboards, memory, or hard disk drives. IBM ships CRUs to you for replacement by you. You must return all defective CRUs to IBM within 30 days of your receipt of the replacement CRU. You are responsible for downloading designated Machine Code and Licensed Internal Code updates from an IBM Internet Web site or from other electronic media, and following the instructions that IBM provides.

When warranty service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part.

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to

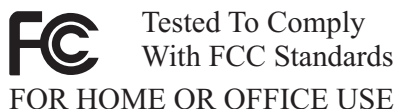
